

Westfield Gas + Electric's appliance rebates are offered to promote the installation of ENERGY STAR® qualified appliances. This program is designed to offset the incremental cost of such systems over standard replacements. Rebates are available to residential customers that have installed eligible systems within the past twelve (12) months.

Eligibility for Rebate:

Applicant must be a current electric customer of Westfield Gas + Electric.

- Reside in a 1-4 unit property; appliances included in a home purchase are ineligible.
- Leased appliances are not eligible for rebates.
- Only new ENERGY STAR® qualified appliances are eligible.
- One rebate for each appliance type every three years.
- Program terms and conditions are subject to change or be cancellation without notice.

How to Apply:

- 1. Purchase qualifying appliance and save your dated sales receipt. A resource for determining eligible models can be found at: www.energystar.gov.
- Apply online at <u>www.wgeld.org</u> and upload required documentation. OR

3. Upload or return the completed application along with a copy of your dated invoice or receipt.

Remember your submission must include:

- a. Copy of your most current electric bill.
- b. Copy of dated receipt, which must include appliance brand, model, serial #, purchase date, and cost.
